

## Entry requirements and admission criteria

The Bachelor's degree in Tourism is open to any qualified person, without any discrimination on the grounds of age, sex, race, religion, disability, sexual orientation, ethnic or national origins or other status.

Access to this Bachelor's degree is made in accordance with the current legislation, contained in Order EDU/124/2011, of 12 May, amending Order EDU/1434/2009, of 29 May, which updates the annexes of Royal Decree 1892/2008, of 14 November, regulating the requirements for access to official university undergraduate degrees and the procedures for admission to state universities in Spain.

In accordance with the current regulations, entry to this degree programme may be granted to those who are in one of the following cases:

- 1. Holders of a Baccalaureate qualification as referred to in articles 37 and 50.2 of Organic Law 2/2006, of 3 May, on Education.
- 2. Students from education systems of EU member States or other States with which Spain has signed International Agreements in this respect, under Article 38.5 of Organic Law 2/2006, of 3 May on Education, who meet the entry requirements in their respective countries for access to university.
- 3. Students from foreign education systems, prior request of recognition of the qualification in the issuing country as equivalent to the Spanish Baccalaureate qualification.
- 4. Holders of one of the following qualifications: *Técnico Superior de Formación Profesional, Enseñanzas Artísticas* or *Técnico Deportivo Superior* corresponding to Sports qualifications under articles 44, 53 and 65 of Organic Law 2/2006, on Education.
- 5. Adults over twenty-five years of age, as provided for in twenty-fifth additional provision of Organic Law 6/2001, of 21 December, on Universities.
- 6. Those who provide evidence of having work or professional experience, through the procedure provided in article 42.2 of Organic Law 6/2001, of 21 December, on Universities, as amended by Law 4/2007, of 12 April, whereby the previous one is amended.
- 7. Adults over forty-five years of age, in accordance with the provisions in article 42.2 of Organic Law 6/2001, of 21 December, on Universities, as amended by Law 4/2007, of 12 April, whereby the previous one is amended.

Those meeting some of the following requirements may also be eligible for access to Bachelor's degree programmes:

- Holders of an official university Bachelor's degree or an equivalent degree.
- Holders of an official university degree including: *Diplomado universitario, Arquitecto Técnico, Ingeniero Técnico, Licenciado, Arquitecto,* or *Ingeniero*, corresponding to prior university degrees or equivalent degrees.



- Students having studied but not completed their university studies abroad or in Spain, or who having successfully completed their university studies abroad have not obtained their recognition in Spain and wish to further their studies at a Spanish university.
- In this case, the university concerned must have recognised at least 30 ECTS credits.
