

Master's Degree in Intervention in Cases of Violence against Women

Competences

This chart of competences offers a visual idea of the curriculum content and the emphasis placed on the competences shown. They are distributed by modules and subjects, thus guaranteeing that all the competences envisaged in the programme are acquired.

Two modules: Specialist area and core area

Specific area

Subject area: **Intervention in gender-based and domestic violence 30 ECTS (COMP.)**

- Identify situations presenting risks, difficulties, conflicts, vulnerability and maladjustment in the three different stages of the violence cycle with a view to implementing the most appropriate personal and family intervention strategies.
- Interact with women who suffer mistreatment to achieve change, promote their development and improve their living conditions by using the proper intervention methods, techniques and procedures as well as a follow-up of the entire process.
- Choose and use a wide range of resources and services to help women suffering gender-based violence.
- Focus on risk behaviours, identify and evaluate the situations and circumstances that make up this behaviour and design strategies to change them.
- Promote the growth, development and independence of women victims of violence, and identify opportunities for them to create groups for individual growth and strengthening of interpersonal skills.
- Design, implement and evaluate projects for social intervention that focus on diagnosis, mediation and/or prevention of violence against women.

Subject area: **External internships 12 ECTS (COMPULSORY)**

- Apply the knowledge acquired and problem-solving capacity in new or little known settings within wider (or multidisciplinary) contexts related to the subject area.
- Become involved and collaborate actively in achieving common objectives with other people, areas and organisations.
- Intervene with women suffering mistreatment and/or men who use violence. Aid them in decision-making concerning their needs, circumstances, risks, preferred options and resources, taking into account the ethical principles of social intervention.

- Design, implement and evaluate projects for social intervention that focus on diagnosis, mediation and/or prevention of violence against women.

Subject area: **Master's Final Project 6 ECTS (COMPULSORY)**

- Inform of one's conclusions- and the knowledge and reasons supporting them- to specialist and non-specialist audiences, making use of clear unambiguous terms.
- Develop the learning skills to continue with independent study.

Core Area

Subject area: **Interdisciplinary Social Intervention 6 ECTS (COMPULSORY)**

- Integrate knowledge and face the complex task of forming judgements based on information which, although incomplete or limited, includes reflections on social and ethical responsibilities linked to application of one's knowledge and judgements.
- Form thought processes and common reference frameworks, taking into account the positions of the members in the work group.

Subject area: **Specific Professional Tools for Social Intervention 6 ECTS (ELECTIVE)**

- Pursue excellence in the professional field, oriented to results and centred on continuous improvement.
- Give a satisfactory response to the needs and demands of people and organisations by modifying or including new features in procedures and results.
